The Principals of certain Government Polytechnics have submitted their proposals towards Annual Physical Verification of Stores, Library to this office to issue orders for condemnation of unserviceable articles, e-Waste and books for the previous financial years. The Principals are informed that, if orders are not issued before March of that financial year, it may be treated that the proposal is not accepted.

This office has instructed the Principals, vide ref (6) cited, to register to the "Konugolu" Portal for e-Auction services of as per Govt orders cited under ref (5). Further the Principals are instructed to intimate this office once the process of registration to the "Konugolu" Portal for e-Auction services is completed. So Principals of Govt Polytechnics are once again instructed to follow the directions issued in memo cited under ref (6).

All the Principals of Government Polytechnics are instructed to submit fresh proposals towards condemnation of all (i) unserviceable articles (ii) Library Books, for the financial year 2021-22, after Physical Verification of the stores/Labs and Library at the institutions.

The Principals are instructed to submit the proposals limiting the total amount not exceeding Rs. 5.00 Lakhs towards condemnation of all unserviceable articles.

Further the Principals are instructed to furnish the data (signed copies and soft copies of the details of unserviceable articles) in the Annexure-I and II.

The proposals (signed copies) may be sent to this office with named cover to "Deputy Director (Technical)" on or before 15-07-2022 by speed post/courier service.
