2. It is further informed that, to recognise the excellence and to improve the quality in Technical Education in all the Government Polytechnics in Andhra Pradesh, it is proposed to apply for Accreditation of the institutions to National Board of Accreditation (NBA) during the academic year 2020-21. It is further informed that, for processing of accreditation applications of Diploma Programmes for NBA., an amount of Rs 1,00,000 +18,000 (GST) towards registration fee and an amount of Rs. 3,50,000/-+63000/-(GST) towards Accreditation Fee for two Programmes(courses), to be paid by the institutions for NBA Accreditation for Diploma courses.

In this context, the Commissioner of Technical Education is pleased to accord sanction for an amount of Rs.74,93,000/- (Rupees Seventy four lakhs ninety three thousand Only) among the (21) Government Polytechnics (Annexure enclosed) under the HOA 2203- Technical Education, 00- Not Applicable, MH 001- Direction and administration, 00- Not Applicable SH-05 Accreditation by a National Board of Accreditation (NBA) for Government Polytechnics, 360- Fees, Fines & Refunds, 361 – Accreditation Fees, for the financial year 2020-21 towards payment of Registration and Accreditation fee for one/two Diploma courses for National Board of Accreditation as requested by the Secretary, SBTET, A.P as cited under ref(4).
