The Department has re-structured the Curriculum (C-16) of all the Branches to incorporate six months industry attachment of the student to an Industry for training in the final year from academic year 2018 -19 from the month of May 2018 onwards.

In this regard, the Special Commissioner of Technical Education, A.P. Vijayawada issued instructions to the Regional Joint Directors AU and SVU Regions and nominated District Coordinating Principals as monitoring authorities vide references 1 &2 cited clearly specifying the duties of all concerned. However, compliance reports have not been received from either the Offices of the RJDs AU and SVU Regions or from the Coordinating Principals regarding the conduct of an Industry Institute Meet and the Training Placements identified for the different Branches of students in the various Districts.

The Regional Joint Directors AU and SVU Regions are therefore instructed to take active interest in directing all the Principals of the Government, Private, Aided, and 2nd Shift Polytechnics in Engineering Colleges where Diploma courses are being offered to concentrate on obtaining Industrial Training Placements and instruct them to report the same to the District Coordinating Principals for consolidation so that all students can be placed in suitable Industries. Proactive participation of all concerned alone can enable the successful implementation of Industrial Training for the final Year students of all Diploma Courses from May 2018 onwards.

Further the Regional Joint Directors are instructed to see that District Level Industry Institute Meets are held at the earliest if they have not been held till now and submit a compliance report in the following in Excel Format only.
