3. Representations / Objections received from Senior Lecturers in Pharmacy of Government Polytechnics concerned.

A Provisional Inter Se Seniority list of Senior Lecturers in Pharmacy (Category 5 of Class B in APTES Rules) those who are in service in Government Polytechnics as on 01-09-2016 was communicated to the individuals concerned vide this office memo 1st cited, with a request to file objections, if any, on or before 28-01-2017. Subsequently, Objections were received from Senior Lecturers in Pharmacy of Government Polytechnics. After careful examination with reference to the records, the objections were disposed off, with necessary replies to the each individual as per **Annexure** enclosed.

2. The final seniority list prepared is based on the following Court orders:

- a) Sri G. Krishnamurthy Naidu and Dr. Y. Sudhakar approached Hon'ble APAT with O.A. No. 3639/2016 on the seniority lists of Senior Lecturers in Pharmacy section. The respondents (3) to (5) are Smt. M. Sumathi, Senior Lecturer in Pharmacy, GPW Kadapa, Smt. K. Sujatha, Senior Lecturer in Pharmacy, GPW, Srikakulam and Sri N. Kishore Kumar Senior Lecturer in Pharmacy, SGPR GPT Kurnool did not respond to the court notices served to them.
- b) The Hon'ble APAT passed Order on the O.A No. 3639/2016 on 30.12.2016 with the following observations.

"the subject matter of this O.A., and the subject matter in O.A.No.4759 of 2005 and batch, is similar and this O.A., may also be disposed of as a covered matter in terms of orders dated 27.4.2010 passed in the above said Batch of cases".

- c) Further, the O.A. No. 4759/2005 was disposed of by the Hon'ble APAT on 27.04.2010 and with the following direction:-

Point (1) of Para (20) states that "Seniority shall be fixed in terms of Rule 33 (a) read with the proviso to Rule 33 (b) of A.P. State and Subordinate Service Rules basing on the merit list prepared by the Appointing Authority on the basis of marks obtained without reference to the roster points".

3. Hence, the Provisional Inter-Se-Seniority List of Senior Lecturers in Pharmacy in Government Polytechnics for those who are in service as on 01.09.2016 is finalised and the final Inter-Se-Seniority list is communicated herewith to the individuals concerned. However, the Seniority is, subject to the outcome of the SLPs/W.Ps/C.As/ O.As/ MAs if

any pending before the Hon'ble Supreme Court of India, High Court of AP., and Hon'ble APAT.

4. The Principals of concerned Polytechnics are requested to communicate the Final Inter-Seniority list of Senior Lecturers in Pharmacy to the individuals concerned duly obtaining acknowledgments from them.
