All the Principals of Government Polytechnics in the state are aware that vide reference 1st cited above, a campaign was conducted for improvement of admissions into Polytechnic colleges for Academic Year 2018-19.

2. In this connection, apart from campaigning in schools, free coaching was also conducted to the students for POLYCET-2018 entrance test at Government Polytechnics across the state from **02.04.2018 to 25.04.2018** by utilizing the services of the Contract lecturers, Guest Lecturers along with available Regular staff members of Mathematics, Physics and Chemistry working in the Government Polytechnics with an aim to improve admissions in POLYCET - 2018.

3. In this regard, while issuing the Instructions in the video conference vide reference 2nd cited, held by the SPL CTE, it has been recommended to pay the Remuneration of Rupees 200/- (Rupees Two Hundred only) per hour to the Contract Lecturers and Guest faculty as per reference 3rd cited. Whereas in case of Regular Staff members it is the part of their duty to promote and encourage appropriate innovative activities initiated by the department to bring about coordinated efforts for the development of Technical Education in the State, hence their services are considered to be purely part of their responsibility and they cannot be paid.

4. In view of the above circumstances, the Principals of Government Polytechnics are hereby permitted to meet the expenditure incurred towards the payment of remuneration to the Guest faculty as per G.O.Ms. No. 55, Higher Education (TE) Department, dated: 06.09.2017 from the head of Account **2203-00-105-00-04-280-284** and other miscellaneous expenditure incurred (i.e. Flexi printing cost) from the available Non- Govt. Funds.

5. Therefore, the Principals of the all the Govt. Polytechnics are requested to adhere the Instructions as mentioned above and submit the compliance report to this office.
