

Documents to be submitted	No Objection certificates from both the colleges along with representation and supporting documents.
Reasons for rejection of applications	Incomplete applications, Over and above the ceiling limit of 1% of sanctioned intake, unfilled vacancy position not furnished, Unsigned / unauthorized NOCs, NOCs issued before commencement Date, Submission after last date, Transfer requested from One University to another University.
